He then underwent surgical training in Birmingham, Derby and Bristol before moving to the University of Louisville in the United States to undertake a research MD. Prof Reed was appointed Dean of BSMS in 2014. During his time as Dean, BSMS has been awarded silver (2018) and gold (2023) in the Athena SWAN scheme.

He is a recipient of the Silver Award from the Chief Nursing Officer for England, and included in a list of 75 nurses and midwives who have contributed in a significant way to the health service, compiled by the Nursing Times to celebrate the 75th anniversary of the NHS.

Michele Salter


